

NOTICE OF OLDER AMERICAN ACT FUNDING AVAILABLE

Every four years, Sourcewise is required to hold a competitive bid process (Request for Proposal/RFP) for Older Americans Act programs which receive an allocation of more than \$100,000. Sourcewise announces the availability of Older Americans Act funding for the Fiscal Year 2020–2021 for: Title III C-2 Home Delivered Meals Vendor award.

Sourcewise is accepting proposals for the following:

• Title III C-2 Home Delivered Meals Vendor: \$1,602,528. The vendor will make and deliver high-quality, cost-effective and nutrition meals to eligible homebound older adults in Santa Clara County. The meal provided to an eligible individual will be delivered to his or her place of residence, that meets all of the requirements of the Older Americans Act and State/Local laws, assures a minimum one-third of the current Dietary Reference Intake per meal, and shall comply with Dietary Guidelines for Americans. Meals can be hot, fresh or frozen.

Eligible Organizations:

Public, non-profit or for-profit organizations located in Santa Clara County are eligible. Non-profit agencies must have a 501(c)(3) status and for-profit organizations must be legally incorporated to safeguard the interests of the State of California and Sourcewise. Contract awards made to for-profit organizations must be approved by the California Department on Aging.

Title III C-2 Program Goal:

Assist older individuals in California to live independently, by promoting better health through improved access to nutrition, and reduced isolation through programs coordinated with nutrition-related supportive service. Aims to ensure older adults remain independent in their communities.

To reduce hunger and food insecurity and increase health and well-being of older individuals by assisting such individuals to gain access to nutrition to delay the onset of adverse health conditions resulting from poor nutritional health or sedentary behavior.

The request for qualified bidders for the delivery of Title III C-2 Home Delivered Meal services may be removed at the discretion of Sourcewise.

July 1, 2020 to June 30, 2021. Contracts may be renewed for up to 3 years, at the discretion of Sourcewise.
