



NOTICE OF FUNDING AVAILABILITY

Every four years, Sourcewise is required to hold a competitive bid process (Request for Proposal/RFP) for Older Americans Act programs which receive an allocation of more than \$10,000.

Sourcewise announces the availability of Older Americans Act funding for the Fiscal Year 2018–2019 for Title III E, Family Caregiver Support Program.

Sourcewise is accepting proposals for the following:

- Community Education on Caregiving: \$45,000 available to a program that educates groups of current or potential caregivers. Services must be targeted to minority populations. Services must be provided in North County.
- Caregiver Training: \$30,000 available to a program that assists caregivers in developing the skills and knowledge necessary to meet and enhance their caregiving roles.
- Grandparent Case Management: \$42,750 available to a program that provides Case Management to Grandparents caring for a child.
- Respite Out-of-Home: \$100,000 to a program that provides respite services in a supervised/protective congregate setting during a portion of the day, and includes access to social and recreational activities. This contract will be awarded to a program that targets minorities. Services must be provided in South County.
- Respite Out-of-Home: \$100,000 to a program that provides respite services in a supervised/protective congregate setting during a portion of the day, and includes access to social and recreational activities. This contract will be awarded to a program that targets care recipients who have Alzheimer's or other dementia.
- Respite In-Home: \$30,000 available to a program that provides respite services for day or overnight supervision and friendly visiting by an appropriately skilled provider.

Eligible Organizations:

Public, non-profit or for-profit organizations located in Santa Clara County are eligible. Non-profit agencies must have a 501(c)(3) status and for-profit organizations must be legally incorporated to safeguard the interests of the State of California and Sourcewise. Contract awards made to for-profit organizations must be approved by the California Department on Aging.

Eligible Clients:

Applicants must have established methods, other than the use of a means test, to provide services to all persons age 60 or over. Applicants must place special emphasis on providing services to persons identified to be in the greatest economic and social need, and proportionate services for low-income, minority elderly individuals.
