Funding Availability:

Proposals must be limited to the amount of funds that correspond to the specific program(s) available in the OARR RFP as stated. Each of the allocations represents a planning estimate provided by the California Department of Aging and is subject to change. Funding is contingent upon the availability of State funds, including the Sourcewise planning process.

Contract Period:

The contract period for programs included in this RFP is a nine-month period from April 1st, 2023, through December 31, 2023. This is a one-time only contract with no renewal option.
