

NOTICE OF MODERNIZING THE OLDER CALIFORNIAN'S ACT (MOCA) NUTRITION FUNDING AVAILABLE INVITATION FOR BID/REQUEST FOR PROPOSAL 10/04/2024

As required, Sourcewise shall hold a competitive bid process known as a Request for Proposal (RFP) for innovative services for the Modernizing the Older Californian's Act (MOCA) programs which receive investment with an aggregate allocation of more than \$100,000. Sourcewise announces the availability of Brown Bag, Grocery Program, Intergenerational Activities, Title III C-1 Congregate Meal Nutrition Services and Title C-2 Home Delivered Meal Nutrition Services funding to administer selected Modernizing the Older Californian's Act programming for the contract period beginning on JANUARY 1, 2025, through MARCH 31, 2026, for:

Proposal Due Date:

Complete paper & electronic proposals must be submitted to Sourcewise or they will not be considered for funding on **Monday, November 4, 2024, at 4:00 p.m.** The below submissions are required:

Funding Availability:

Proposals must be limited to the amount of funds that correspond to the specific program(s) available in the MOCA RFP as stated. Each of the allocations represents a planning estimate provided by the California Department of Aging and/or Federal Government and is subject to change. Funding is contingent upon the availability of federal funds, including the Sourcewise planning process.

Contract Period:

January 1, 2025, to March 31, 2026. A contract renewal up to one year following the initial contract year is allowable at the discretion of the Area Agency on Aging (AAA) which is subject to annual renegotiation and availability of federal, state, and local funding. The renewal contract term is from April 1, 2026, to March 31, 2029.
