All bidders must complete and return the letter of intent; partial submissions and **alternative formats will not be accepted.**

Proposal Due Date:

Complete paper & electronic proposals must be submitted to Sourcewise, or they will not be considered for funding on **Tuesday, February 25, 2025, at 4:00 p.m.** The below submissions are required:

Funding Availability:

Proposals must be limited to the amount of funds that correspond to the specific program(s) available in the Older Americans Act (OAA) Programs RFP as stated. Each of the allocations represents a planning estimate provided by the California Department of Aging and/or Federal Government and is subject to change. Funding is contingent upon the availability of federal funds, including the Sourcewise planning process.

Contract Period:

April 1, 2025, to June 30, 2025. A contract renewal for up to three years following the initial contract year is allowable at the discretion of the AAA which is subject to annual renegotiation and availability of Federal, State, and local funding. The renewal contract term is from July 1, 2025, to June 30, 2026.
