All bidders must complete and return the letter of intent; partial submissions and <u>alternative</u> <u>formats will not be accepted</u>.

Proposal Due Date:

Complete paper & electronic proposals must be submitted to Sourcewise, or they will not be considered for funding on Wednesday, May 28, 2025, at 4:00 p.m. The below submissions are required:

Funding Availability:

Proposals must be limited to the amount of funds that correspond to the specific program(s) available in the Modernizing Older Californians Act (MOCA) Nutrition Programs RFP as stated. Each of the allocations represents a planning estimate provided by the California Department of Aging and/or Federal Government and is subject to change. Funding is contingent upon the availability of federal funds, including the Sourcewise planning process.

Contract Period:

July 1, 2025, to March 31, 2026. A contract renewal for up to three years following the initial contract year is allowable at the discretion of the AAA which is subject to annual renegotiation and availability of Federal, State, and local funding. The renewal contract term is from April 1, 2026, to March 31, 2027.
